Purpose: This form is to be used by architect/engineers, pool builders, or owners to apply for a permit to construct a recreational water facility.

ITEM BY ITEM INSTRUCTIONS FOR COMPLETING THIS FORM:

SECTION 1. PLANS AND ENGINEER:

Enter the date of the plans and specifications in the first space, the name of the S.C. Registered Architect/Engineer who prepared the plans and specifications in the second space, the number of the S.C. Registered Architect/Engineer who prepared the plans and specifications in the third space and the appropriate application fee in the fourth space. Fees are based on the following computation schedule:

Construction Permit Application Fee Schedule:

- (i) Type "A," "B," "C," "D," and "F" Pools (as defined in Regulation 61-51) - \$400.00 plus \$0.50 per square foot of pool area.
- (ii) Type "E" Pools (as defined in Regulation 61-51) - \$1,000.00 per flume (including minimum required design landing area). All other Type "E" pools will be charged according to (i) above.

Enter the address and phone number of the S.C. Registered Architect/Engineer in the next two (2) spaces.

SECTION 2. POOL DETAILS:

Enter the full name of the facility, the physical location of the facility, to include the street or road, city, state, and zip code. Also enter the county and the phone number at the facility.

SECTION 3. CONSTRUCTION RESPONSIBILITIES

Check the pool type (A,B,C,D,E,F per regulations) to be constructed or altered in the appropriate space. In the left column of Section 3 enter the perimeter in linear feet, the volume in gallons, the design flow rate in gallons per minute, and the number of people, per regulations, that the pool to be constructed or altered can safely accommodate in the appropriate spaces. In the right column of Section 3, check YES or NO to indicate whether or not the pool will be used year round. Check IN or OUT to indicate whether the pool will be located indoors or outdoors. Enter the area in square feet, the minimum flow rate in gallons per minute, the total deck area in square feet, and the number of people, per regulations, that the deck surrounding the pool to be constructed or altered can safely accommodate in the appropriate spaces.

Check Appropriate Column (Owner - O, Builder - B, or Not Applicable - N)

Review each listed item. Determine whether the builder or the owner will be responsible for the item or if the item is not applicable to this facility. Place an X, or a check mark, in the appropriate column.

SECTION 4. POOL BUILDER:

In the left column enter the company name and complete mailing address, including zip code, of the pool builder who will be constructing or altering the pool. In the right column enter the primary contact person, telephone number including area code, and the S.C. Swimming Pool Contractor's license number (required for projects of \$5000 or more).

SECTION 5. OWNER:

In the left column enter the name of the owner's company (if applicable), the owner's telephone number, including area code, and print the name to be signed on the application. In the right column enter the owner's complete mailing address, including zip code and the date the application was signed. The owner, or designated representative, must sign the application (**the signature must be original**).

Office Mechanics and Filing: This form should be filed in the Recreational Waters File Room according to assigned facility permit number.
